Documents Required For MO HealthNet Planning

- 1. Social Security cards
- 2. Medicare card and any additional health insurance card(s)
- 3. Current health insurance premium verification (i.e., a billing statement)
- 4. All life insurance verification with verification of their current cash surrender value(s). Please note that the face value does not correspond with the cash value. Please bring a copy of the life insurance policy to your appointment.
- 5. Copies of prepaid burial plans with verification of their irrevocability, if applicable.
- 6. Copies of bank statements for the month of application and the last <u>three</u> months including copies of cancelled checks.
- 7. Verification of the disposition of all large checks (over \$200)
- 8. Verification of any recently closed accounts, showing a zero balance (in the previous <u>three</u> months)
- 9. Copies of Powers of Attorney, guardianship, conservatorship or trust papers.
- 10. Complete copies of contracts of all annuities.
- 11. Verification of the values of all CD's, stocks, bonds, and other investments (complete statements).
- 12. Real estate deeds and verification of the amount owed, if any.
- 13. Car titles(s).
- 14. Verification of the gross Social Security amount and the gross amount of all other pension(s).
- 15. Verification of all transfers of property over the last 5 years.
- 16. Birth verification.
- 17. If under 65 then provide one of the following:
- 18. Verification of Social Security Disability; verification of Supplemental Security Income or a complete list of all doctors and hospitals to obtain medical records from.

In addition, the following items are also needed in cases with spouses:

- 1. Marriage verification.
- 2. Copies of last three utility bills with the address.
- 3. Verification of rent or house payments.
- 4. Verification of condominium maintenance fees, if applicable.
- 5. Most recent real estate tax and home owner's insurance payments.
- 6. Verification of all gross income for the community spouse (including interest and dividends).
- 7. Verification of the first 30 days of institutionalization (defined as the first 30 continuous days in a hospital and/or vendor certified bed in a nursing facility.
- 8. Verification of all the value of all assets for the month of institutionalization if different from the month of application.

- 3. Verification of all of the dependent's income.
- 4. Copy of the most recent income tax statements verifying dependent status.
